Subject: Mandatory Pre-Bid Meeting Minutes for Pedestrian improvements and concrete curb ramp

The above subject pre-bid meeting was held on site at the NCDOT Division 13 Conference Room, 55 Orange St, Asheville, NC 28801 as described in the proposal and the Notice to Prospective Bidders on Thursday, September 5, 2024. Attendee roster is attached for reference.

Mr. Chad Loftis called the meeting to order at 8:35 AM after all attendees were signed in. Mr. Loftis explained that any questions asked of him after this meeting and any answers would be distributed to all parties in attendance.

Meeting topics discussed were as follows:

Planned Addendums:

- Revised ICT #2 to restrict any daytime work to delivery and placement of concrete only.
- Will be adding language to make any sign relocation incidental to ramp work.
- Will be adding language to Measurement and Payment of Pedestrian Channelizing Devices. To be paid as the maximum number of linear feet for each approved device satisfactorily installed and accepted at any one time during the life of the project. Measurement will be made of the total length of each barricade along one rail. Relocation, replacement, repair, maintenance or disposal of Pedestrian Channelizing Devices will be incidental to the work of this section. Change contract quantity to 100 LF.
- Changing note on detail sheet 50. Cast iron detectable warnings will be required at locations in town and in Biltmore Village.

- **Special Provisions**
 - Removal means Items will be removed and regraded to meet existing conditions.
 - Removal and Replace will cover items being removed and replaced in the existing
 - Remove Curb and gutter will be for all sizes of Curb and Gutter
 - Antique Brick Curb Ramp
 - Brick will be submitted at Pre-Construction conference after award of contract to be approved by City of Asheville.
 - NCDOT intention is to match but provide uniformity in all handicap ramps.
 - Remove and replace detectable warning plates is for only the Biltmore Village detectable warning plates being replaced.
 - Remove Concrete Curb ramps is to remove curb ramps to nowhere.
 - o Pedestrian Signal Removal
 - Old equipment to be returned to NCDOT Traffic Services
 - Coordinate with NCDOT Traffic Services when relocating signal
- NCDOT has worked to account for all items for the contactor to produce a comprehensive bid but some quantities may need to be field adjusted.
- Electronic Asphalt Ticketing is available if the contractor chooses to use.

Ouestions from Bidders

- Contractor asked about the traffic from I-26 being diverted to US 25 because of I-26 detours and delays in may cause on this project.
 - If this becomes an issue on the project then proper accommodations would be considered for whoever was awarded the contract.
- What size is the water line attached to the Fire hydrants
 - NCDOT would look into this and respond.
- Would there be any need for Temporary Curb Ramps?
- With the 7 day install time of the Curb Ramps could that be adjusted when installing the Antique Curb ramps?
 - This 7 day install time could be adjusted if proper pedestrian detours arein place and NCDOT agrees adjusting the timeframe is warranted
- Contractors still need to go through interested Parties.
