The North Carolina Department of Transportation is requesting bids for guardrail, guiderail, and fence installation, replacement, and repair upon request along various interstate, primary, and secondary routes in Burke, McDowell, Mitchell, and Rutherford Counties.

The availability date for this renewable contract is **November 1, 2019**.

The completion date for this renewable contract is **October 31, 2020**.

Sealed bids must be received in the NC Department of Transportation Division Office at 55 Orange Street, Asheville, NC 28801 by 2:00 p.m. on Wednesday October 2, 2019. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

In order for all prospective bidders to have an extensive knowledge of the project, all prospective bidders shall attend a mandatory pre-bid conference on Thursday September 26, 2019 at 2:00 PM at the NCDOT Division 13, District 1 Marion District Office located at 3931 NC 226 South, Marion, NC 28752 as described in the proposal.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting a bid**.

Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
