Sealed bids must be received in the NC Department of Transportation Division Office at 55 Orange Street, Asheville, NC 28801 by 2:00 p.m. on Wednesday October 16, 2024. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:
