Project Description: Emergency On-Call Asphalt Paving & Asphalt Pavement Repair

The North Carolina Department of Transportation is requesting bids for emergency on-call asphalt paving & asphalt pavement repair in Buncombe, Madison, and Yancey Counties to be let at 2:00 PM on Thursday, October 31, 2024.

The availability date for this project is **November 8, 2024**.

The completion date for this project is **November 7, 2025**.

EMERGENCY BID REQUIREMENTS

This is an Emergency Response contract and as such, the Department has determined that it is not feasible nor in the public's interest to comply with statutory bidding requirements in obtaining equipment and/or contractors for assistance in our cleanup efforts. This is being done pursuant to the authority granted by G.S. 136-28.1 (e). As a result, the following changes apply to this contract:

Any firm that wishes to bid as a prime contractor shall be prequalified with NCDOT as a Bidder or PO Prime Contractor or have the ability to become prequalified for the work being performed within 14 days of receipt of the contract. . A minimum of 3 contractors will be solicited to bid for work on this contract.
