Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified <u>prior</u> to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior</u> to beginning work on the project.
