This letter is to advise all prospective bidders of the following contract addendum:

- Revised the **GUARANTEES** provision on page G-27 to include the following statement:

“All written estimates must contain a warranty statement guaranteeing the roadway platform stability for the repaired section for a period of **five (5)** years and that any necessary repairs will be made in a timely manner at no cost to NCDOT. This warranty statement must be jointly endorsed by the Contractor and the Contractor’s Engineer.”

- Revised **GEOTECHNICAL STABILIZATION** provision on page GT-9 to include the following pay items:
Micropiles up to 20’, Micropiles up to 30’, Micropiles up to 40’, Micropiles up to 50’,
Micropiles up to 60’, Micropiles up to 70’, and Micropiles up to 80’
- Revised the unit of measure of contract item MICROPILES UP TO 50’, line number 36,
from LF (Linear Foot) to EA (Each).
- Revised the unit of measure of contract item MICROPILES UP TO 60’, line number 37,
from LF (Linear Foot) to EA (Each).
- Replaced the 12105988 Proposal document on the Division 13 Letting page with the revised
proposal document 12105988 Proposal – Addendum 1.
