Project Description: To install (Crown) Zoysia sod for thirty-five (35) median inlands. The work consists of

applying herbicides, rotovating and installation of (Crown) Zoysia sod and watering.

The North Carolina Department of Transportation is requesting bids for (Crown) Zoysia Sod along US 19 at California Creek to the Yancey and Madison County Line and along US 19 & 19E in Yancey County to Phipps Creek Road (SR 1136) and Old US 19E. The Contractor is to furnish labor, material, equipment, and traffic control for installation of approximately 28,000 LFT of Zoysia Sod.

The availability date for this project is March 1, 2015

The completion date is April 20, 2015

Sealed bids must be received in the NC Department of Transportation Division Office at 55 Orange Street, Asheville, NC 28801 by 2:00 p.m. on Wednesday, October 15, 2014. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified <u>prior to submitting your bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior to beginning work on the project</u>.
