The completion date for this project is June 30, 2016

Sealed bids must be received in the NC Department of Transportation Division Office at 55 Orange Street, Asheville, NC 28801 by 2:00 p.m. on Wednesday, November 18, 2015. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.

It shall be the responsibility of the bidder to check our website for any addenda prior to submitting their bids. **Bids submitted without project addenda included will not be considered for award.**


