I am pleased to inform you that **Rogers Group, Inc.** has been awarded the contract for the above project based on the bid submitted on **January 12, 2021** in the amount of \$2,968,197.62.

The Good Faith Effort that was submitted by Rogers Group, Inc. was deemed to be lacking in sufficient evidence and documentation that the Good Faith Effort process, as outlined in the proposal, was followed. However, a three-year history of your company's record of meeting goals, shows that you have done so consistently. As such, this award is contingent upon Rogers Group, Inc. agreeing to additional DBE/GFE training to be provided by Business Opportunity & Workforce Development (BOWD). BOWD staff will be contacting you to arrange for this additional DBE/GFE training.

Please provide the following documents to the Division 14 Contract Office within **14** calendar days from the date you receive your award letter:

- 1. An executed letter, on company letterhead, agreeing to the additional DBE/GFE training.
- 2. A current certificate of insurance on an **ACORD** form. The certificate of insurance must verify coverage as required by Article 107-15 of the *Standard* Specifications and must name the State of North Carolina as an additional insured on the commercial general liability policy. The contract ID must be listed on the form. The certificate of insurance should be returned to me.
- 3. A properly executed **Execution of Contract Non-Collusion, Debarment and Gift Ban Certification**. The Execution Forms (Post-Bid) are available on the NCDOT web site at <a href="https://connect.ncdot.gov/letting/Pages/Central-Letting-Forms.aspx">https://connect.ncdot.gov/letting/Pages/Central-Letting-Forms.aspx</a>.
- 4. Two (2) original sets of executed Payment and Performance bonds, including power of attorney. The bond forms are available on the NCDOT web site at <a href="https://connect.ncdot.gov/letting/Pages/Central-Letting-Forms.aspx">https://connect.ncdot.gov/letting/Pages/Central-Letting-Forms.aspx</a>. Bonds should be returned to me.

Please remember that work may not start before the contract has been properly executed.

In addition, your attention is directed to Articles 107-16, 108-1, 108-2 and 108-3 of the *Standard Specifications* relative to prosecution of work, progress schedule and preconstruction conference. Also, in accordance with Article 104-2 of the *Standard Specifications*, it will be necessary for you to submit the name of those individuals within your organization who will be authorized to sign supplemental agreements that may be necessary in the performance of the work under this contract. Information regarding these items should be addressed prior to beginning work.
