- 2. A properly executed **Execution of Contract Non-Collusion, Debarment and Gift Ban Certification**. - 3. Two (2) original sets of executed Payment and Performance bonds, including power of attorney. The bond forms are available on the NCDOT web site at <a href="https://connect.ncdot.gov/letting/Pages/Central-Letting-Forms.aspx">https://connect.ncdot.gov/letting/Pages/Central-Letting-Forms.aspx</a>. Bonds should be returned to me.

Please remember that work may not start before the contract has been properly executed.

Information regarding these items should be addressed prior to beginning work.
