PROJECT SPECIAL PROVISIONS Utility Construction

Revise the 2018 Standard Specifications as follows:

Page 15-18; Section 1540. The steel encasement pipe for the steel well sleeve at approximately station 11+90 -L- shall meet the requirements of Article 1036-4(B). No other materials may be used.

Measurement and Payment:

Steel Encasement shall be measured from end to end and paid at the contract unit price per linear foot. Such price and payments will be full compensation for all labor, materials, excavation, backfilling and any incidentals necessary to complete the work as required.
