Item 4 Prebid Conference

Refer to the Project Manual, Advertisement for Bids and the Notice to Bidders and Instructions to Bidders, page 6 "Pre-bid Conference". A prebid conference was held on January 9, 2019 at 11:00 PM. The sign-up sheet from the Prebid Conference is attached, Attachment 1. The architect and owner summarized requirements included in the Project Manual and contractors were given an opportunity to ask questions and review the work on site. Item 5 BID BOND FORM

Refer to the Project Manual, Notice to Bidders, Instructions to Bidders and the Bid Bond Form. Use only the Bid Bond Form included in the Project Manual.

Item 6 REQUESTS FOR SUBSTITUTION

Refer to the Project Manual, Instructions to Bidders, Paragraph 12. Substitution requests shall be made prior to 3 PM on Sunday, January 27, 2019.

Item 7 SOILS TESTING

Refer to the Project Manual General Conditions, Article 13, Paragraphs d & e and "Earth Moving", Division 31 2000. Third party soils testing will be provided by the owner and the cost of service will be borne by the owner. The retesting of substandard earthwork will be borne by the contractor. The contractor shall notify the soils engineer when work is scheduled and provide loaded trucks for proofrolling as required by the engineer.

Item 8 SALES TAX REPORTING

Refer to the Project Manual General Conditions, Article 32, Paragraph e and Article 45. Every pay application shall be accompanied with a sales tax report as described in Article 45. Pay applications will not be processed in the absence of proper sales tax documentation.

Item 9 PAYMENT OF SUBCONTRACTORS

Refer to the Project Manual Article 32, Paragraph b2 and the Supplementary General Conditions. Add the following paragraph H to the Supplementary General Conditions:

H. Article 33 – Payment of Subcontractors and Suppliers

The Contractor shall make payment to subcontractors and suppliers within 7 days of receipt of payment from the owner for their portion of the work for which the owner has made payment.

Item 10 CONCRETE AGGREGATE

Refer to the Project Manual "Concrete", Division 03 3000, "Unit Masonry" 04 2000 and "Concrete Paving", Division 32 1313. Aggregate for footings and slabs shall be nominal 3/4" aggregate. 3/8" aggregate may be utilized for block fill.

Item 11 GUTTERS AND DOWNSPOUTS

Refer to the Project Manual "Metal Roof Panels" 07 4113 and Drawings Details 12/A-2 & 7/A-3. All gutters and downspouts shall be painted steel per Division 07 4113, Paragraph 2.05, B. Downspouts shall be 4" x 4" square. Brackets shall be as indicated in detail 12/A-2. Locate brackets for all downspouts at the same elevation. Provide an adapter boot to transition from square downspout to round storm drain piping shown in detail 7/A-3.

Item 12 METAL ROOFING SYSTEMS

Refer to the Project Manual "Metal Roof Panels" 07 4113 Paragraph 2.01, Manufacturers. The MRS System 2500, MRS M16 Panels and MRS Flush Seam Panels as manufactured by Metal Roofing Systems, Inc. (MRS) are acceptable for use on this project, subject to compliance with project specifications and provided that the installation complies with MRS requirements for issuance of their full roof, sheet metal and finish warranties. All metal products included in Division 07 4113 shall be provided by the same manufacturer.

Item 13 PAINTED GYPSUM BOARD

Refer to the Project Manual "Painting and Coating" 09 9000 and the Drawings Sheet A-3, Details 1/A-3, 6/A-3 & 8/A-3. All exposed gypsum board shall be painted per specifications. Provide a 1/4" caulked joint between the edge of gypsum board and all other materials.

Item 14 ACCESSIBLE ROUTE TO EXISTING BUILDING

Refer to the Drawings Sheet C1.0. The 5' wide accessible route indicated in the center of the drawings with dashed lines is to be provided with diagonal crosswalk paint as required by code. New concrete walks are indicated by solid lines.

Item 15 CONCRETE SLAB CONTROL JOINTS

Refer to the Drawings Sheet S1.1 and Detail 3/S2.1. The floor joints indicated on sheet S1.1 are control joints. Construction joints, also indicated in Detail 3/S2.1, may be utilized should the contractor opt to install the slab in more than one pour.

Item 16 PRIMARY ELECTRICAL SERVICE

Refer to the Drawings Sheet C1.0 and E0.3 and detail 2/E0.3. Note 7 on Sheet C1.0 refers to electrical service to the building. Conduit and concrete encasement indicated in detail 2/E0.3 for primary electrical service to the building shall be provided and installed by the electrical contractor. The electrical contractor is responsible for the coordination of electrical service with the electrical utility company. The electrical contractor is not responsible for costs associated with the extension of electrical service under the highway if such extension is required.
