Bids will be downloaded and publicly read at NCDOT Division 14 Office, 253 Webster Road, Sylva NC, at the above date and time; however, in-person attendance is not permitted at this time. Interested parties may call the phone number listed under the COVID-19 RESTRICTED BID OPENING ATTENDANCE information found elsewhere in this document.

### **BIDDER REQUIREMENTS**

Bidders must be prequalified as Bidder or PO Prime Contractor at the time of letting, in order to be considered responsible.
