Contract Overview

- Contract IDs: DN12210045 (Federal Funded) & DN12210046 (State Funded)
- Division 14 Counties: Cherokee, Clay, Graham, Haywood, Henderson, Jackson, Macon, Polk, Swain, Transylvania
- Bid Opening: March 10, 2026
- Project Scope: ID/IQ Work Zone Traffic Control

Work Zone Traffic Control (WZTC) IDIQ – Contractor Q&A Meeting Minutes

1. Work Order Acceptance Window

Contractors asked whether the 72-hour confirmation requirement was accurate.

- NCDOT confirmed that contractors have **72 hours (3 days)** to accept a work order.

2. Flagger Staffing Requirements

Roadmasters noted they often send a third flagger for two-lane closures to allow rotation.

- NCDOT clarified that a rotational third flagger is **incidental** to the line item.
- A third flagger required for **traffic management** (side street, intersection, etc.) qualifies as an **additional pay-item flagger**.

3. Measurement of Work Zone Signs

A question was raised about determining 1000 linear feet of signage.

- NCDOT clarified that signage quantities are measured in **square feet**, not linear feet.

4. Additional Truck Mounted Attenuator (TMA)

Contractor asked how to handle situations needing a second TMA.

- NCDOT responded that an additional TMA would require a **supplemental**.

5. Definition of “Day” for Line Items

Contractors requested clarification on whether line-item “day” means 8 or 10 hours.

- NCDOT confirmed a **day = 8 hours**.
- Any hours beyond 8 will be paid under the **lane closure per hour** line item.

6. Minimum Hours for Pay

Questions arose regarding minimum billable hours.

- NCDOT established a **4-hour minimum** for items listed under “days.”
- Contractors may decline work orders if they do not meet this minimum.

7. Mobilization to an Additional Site

Contractor asked how relocating to another site is paid.

- NCDOT stated this is treated as an **additional lane closure setup**, paid either **per-day or hourly**, depending on the work order.

8. Emergency Mobilization

Clarification sought regarding definition and timing.

- Emergency mobilization applies to requests made with **less than 24 hours' notice**.
- Contractor must be onsite within **24 hours** or payment for the item will not be issued.

9. Pedestrian Transport Requirements

Contractor asked how pedestrian transport should be handled.

- NCDOT responded that these cases are rare and the contractor may determine the **best method**.

10. Use of AFADs (Automatic Flagger Assistance Devices)

Roadmasters asked whether DOT will identify roads where AFADs cannot be used.

- NCDOT confirmed that a **DOT representative will specify** roads where AFADs are or are not allowed.
