OTHER INFORMATION

Bidders must attend the pre bid meeting and sign the sign in sheet to be considered a valid plan holder; bidders should bring a printed copy of the proposal, plans, and any relevant supplemental documentation to the pre-bid meeting, as hard copies of these documents will not be supplied by NCDOT.

The contract proposal is available online at https://connect.ncdot.gov/letting/Pages/Division.aspx. The printing of all bid-related documents, including the proposal, plans, and any supplemental project information shall be the responsibility of the bidder. Division 14 will no longer provide hard copies of bid documents. (Bidders must request a validation email from

<u>d14contracts@ncdot.gov</u> to be considered a valid plan holder.) Supplemental project information and addendums will be posted at https://connect.ncdot.gov/letting/Pages/Division.aspx.

Bidders must be prequalified as Bidder or PO Prime Contractor at the time of letting in order to be considered responsible. Information about prequalification can be found at https://connect.ncdot.gov/business/Prequal/Pages/Default.aspx.

Electronic bidding is acceptable.

As of September 2016 Division 14 can accept electronic bids through Bid Express®.
