The contractor shall arrive on site within four (4) hours of notification.

MOBILIZATION AND LIQUIDATED DAMAGES: (4-8-09) (Rev. 4-23-19) 800

SPD 08-100

Description

"Routine mobilization" is defined as the cost of mobilizing for routine signal repair, maintenance, or installation. The Department may or may not provide the Contractor a list of locations to be repaired or maintained at each notification. Routine repairs and maintenance for damaged outdated signal or signal related equipment will have no minimum limits and the Contractor shall consider this when submitting his bid. The Contractor shall report to the specified location within 21 calendar days after notification, except for emergency and metal pole notification, as stated elsewhere in this contract.

Revise the 2018 Standard Specifications as follows:

Page 8-1, add the following as new Article 800-1.5:

800-1.5 EMERGENCY MOBILIZATION

The Contractor shall arrive on site within four (4) hours of notification.

Page 8-1, Article 800-2 MEASUREMENT AND PAYMENT, replace the first paragraph with the following:

Routine Mobilization will be paid at the contract unit price per each initial mobilization. Relocation within the Division is considered incidental to the contract bid price.

Emergency Mobilization will be paid at the contract price per each emergency mobilization notification. Once mobilized for an emergency repair, relocation for emergency or routine installation and repairs within the Division is considered incidental to the initial notification.

Metal Pole Mobilization will be paid at the contract unit price per each initial mobilization. Relocation within the Division is considered incidental to the contract bid price. Each mobilization is restricted to 120 calendar days from the time of notification to completion.

The Contractor will only be paid one mobilization (routine, emergency, or metal pole) for each notification.

Liquidated damages for failure to report to or begin work within the above specified time will be charged according to the following:

Liquidated damages for routine mobilization are One Hundred Dollars (\$100.00) per day per each notification beginning at the end of the twenty-one day routine notification time period.
