The certificate of insurance must verify coverage as required by Article 107-15 of the *Standard Specifications* and must name the State of North Carolina as an additional insured on the commercial general liability policy. The contract ID must be listed on the form. The certificate of insurance should be returned to me.


Please remember that work may not start before the contract and work order assignment has been properly executed.

Information regarding these items should be addressed prior to beginning work.
