- 2. A properly executed **Execution of Contract Non-Collusion**, **Debarment and Gift Ban Certification**. The Execution Forms (Post-Bid) are available on the

- 3. A completed Steel Price Adjustment form SPA-1. A link to this document can be found in the proposal document.
- 4. Two (2) original sets of executed Payment and Performance bonds, including power of attorney. Bonds should be returned to me.

Please remember that work may not start before the contract has been properly executed.
