I am pleased to inform you that **Williams Construction & Cabinetry** has been awarded the contract for the above project based on the bid submitted on **May 11, 2021** in the amount of \$1,345,659.92.

The Good Faith Effort that was submitted by Williams Construction & Cabinetry was found to be in Good Faith Effort (GFE), but it was evident that the GFE process, as outlined in the proposal, was not followed, as it is intended to be. As such, this award is contingent upon Williams Construction & Cabinetry agreeing to additional DBE/GFE training to be provided by Business Opportunity & Workforce Development (BOWD). BOWD staff will be contacting you to arrange for this additional DBE/GFE training.

1. An executed letter, on company letterhead, agreeing to the additional DBE/GFE training.

The certificate of insurance must verify coverage as required by Article 107-15 of the *Standard* Specifications and must name the State of North Carolina as an additional insured on the commercial general liability policy. The contract ID must be listed on the form. The certificate of insurance should be returned to me.
- 3. A properly executed **Execution of Contract Non-Collusion, Debarment and Gift Ban Certification**. The Execution Forms (Post-Bid) are available on the NCDOT web site at <u>https://connect.ncdot.gov/letting/Pages/Central-Letting-Forms.aspx</u>.
- Two (2) original sets of executed Payment and Performance bonds, including power of attorney. The bond forms are available on the NCDOT web site at https://connect.ncdot.gov/letting/Pages/Central-Letting-Forms.aspx. Bonds should be returned to me.

Please remember that work may not start before the contract has been properly executed.

In addition, your attention is directed to Articles 107-16, 108-1, 108-2 and 108-3 of the *Standard Specifications* relative to prosecution of work, progress schedule and preconstruction conference. Also, in accordance with Article 104-2 of the *Standard Specifications*, it will be necessary for you to submit the name of those individuals within your organization who will be authorized to sign supplemental agreements that may be necessary in the performance of the work under this contract. Information regarding these items should be addressed prior to beginning work.
