1. A current certificate of insurance shall be provided on the latest revision of the **ACORD** 25 form. The certificate of insurance shall verify coverage as required by Article 107-15 of the *Standard* Specifications as well as by provision SP1 G05, *Liability Insurance* found in the general section of the proposal. Endorsements for additionally ensured shall be included for those types of insurances being used to meet the required liability / umbrella coverages. The certificate of insurance may be sent as an email attachment, directly from your agent or from you, or it may be mailed, shipped, or hand-delivered to the mailing address shown in the footer of the first page of this award letter.

2. A properly executed **Execution of Contract Non-Collusion, Debarment and Gift Ban Certification**; this includes all three pages; don't forget the header information on the last two pages. This document shall be submitted as **hard-copy, originals** to the mailing address shown in the footer of the first page of this award letter; it may be mailed, shipped, or hand-delivered. 3. Two (2) original sets of executed Payment and Performance bonds, including power of attorney. These bonds must include the date to be considered properly executed; without the date, NCDOT will not execute the contract. These documents shall be submitted as <a href="https://contract.ncbot.gov/letting/Pages/Central-Letting-Forms.aspx">hard-copy</a>, originals to the mailing address shown in the footer of the first page of this award letter; these may be mailed, shipped, or hand-delivered. Please remember that work on the project is not to begin before the contract has been properly executed.

Please forward the remaining information to the Resident Construction Engineer, Mike Patton, as soon as possible so that a preconstruction conference can be held.
