





The above contract has experienced the following revision:

- On the **cover page**, revise the DATE AND TIME OF BID OPENING to read: **AUGUST 8, 2017 AT 2:00 PM.**
- **Replace** pages **G-4 and G-5**, with the attached revised pages.
- On page **G-6**, under **SP1 G-10A CONTRACT TIME AND LIQUIDATED DAMAGES**: revise the dates as follows:

The date of availability for this contract is **September 4, 2017.**

The completion date for this contract is **October 30, 2017.**

- On page **G-7** under **SP1 G43 FUEL PRICE ADJUSTMENT**, third paragraph: revise the first sentence to read as follows:

The base index price for DIESEL #2 FUEL is \$ **1.4426** per gallon.

- On page **G-25** between **SP2 R02A, CLEARING AND GRUBBING - METHOD II**: and **SP6 R01 ASPHALT PAVEMENTS - SUPERPAVE**:, insert the following special provision:

Revise the *2012 Standard Specifications* as follows:

Page 6-4, Article 607-1, Description, in the second line of the first sentence, replace the word “pavement” with the phrase “concrete pavement bridge approaches.”

Pages 6-5 through 6-7, Articles 607-2 through 607-5 Equipment, Construction Methods, Tolerance, and Measurement and Payment, respectively, replace the word “asphalt” with the word “concrete,” at all occurrences.

Pages 6-6 through 6-7, delete **Articles 607-5(B), 607-5(C), and 607-5(D)**.

Page 6-7, under Pay Item and Pay Unit, delete Milling Asphalt Pavement, ___” to ___” and Square Yard, respectively.

Page 6-7, under Pay Item and Pay Unit, delete Incidental Milling and Square Yard, respectively.

- On pages **G-30 under SP6 R25 PRICE ADJUSTMENT - ASPHALT BINDER FOR PLANT MIX:**, second paragraph: **revise** the first sentence to read as follows:

The base price index for asphalt binder for plant mix is **\$ 384.50** per ton.

- **Replace pages T-1 and T-2**, with the attached revised pages; these include the following revisions:
 - **Addition** of pay item # **1891000000-E, 2” MILLING CONCRETE PAVEMENT**, at **200 SY**.
 - The quantity for **pay item # 0004, 1297000000-E, MILLING ASPHALT PAVEMENT, ***" DEPTH (2)** has been **reduced by 200 SY**

See the attached revised pay item sheets **T-1 and T-2**.

Please delete the EBS file and EBS Addenda file(s) that you previously downloaded for the July 25, 2017 letting and download the new EBS file listed for the August 8, 2017 letting. Bid Express will not accept your bid unless the new EBS file associated with the August 8, 2017 letting is used.

Please note: Addendum #1 has been reissued, but ignore the instruction, contained within it, to download the associated EBS Addendum file, as these changes have now been incorporated into the new EBS file.

Please insert this letter into the addendum section of the proposal and sign the verification. Thank you for your attention to this matter.

INSTRUCTIONS TO BIDDERS

**PLEASE READ ALL INSTRUCTIONS CAREFULLY
BEFORE PREPARING AND SUBMITTING YOUR BID.**

All bids shall be prepared and submitted in accordance with the following requirements. Failure to comply with any requirement may cause the bid to be considered irregular and may be grounds for rejection of the bid.

ELECTRONIC BID PREPARATION WITH MANUAL DELIVERY:

1. Download the entire proposal and EBS file from the Connect NCDOT website and return the entire proposal with your bid.
2. Expedite software necessary for electronic bid preparation may be downloaded from the Connect NCDOT website at: <https://connect.ncdot.gov/letting/Pages/EBS-Information.aspx>
3. Bid shall be prepared in Expedite, printed, signed and placed in paper proposal. The EBS file should be saved to a CD and submitted with signed paper proposal.
4. The Bidder shall submit a unit price for every item on the itemized proposal sheet. The unit prices for the various contract items shall be written in figures. Unit prices shall be rounded off by the Bidder to contain no more than FOUR decimal places.
5. Changes to any entry shall be made to the EBS file, reprinted, signed and placed in the paper proposal. The corrected file shall be saved to a CD and submitted with signed paper proposal.
6. The bid shall be properly executed on the included **Execution of Bid – Non-collusion Affidavit, Debarment Certification and Gift Ban Certification** form. All bids shall show the following information:
 - a. Name of corporation, partnership, Limited Liability Company, joint venture, individual or firm, submitting bid.
Corporations that have a corporate seal shall include it on the bid.
 - b. Name of individual or representative submitting bid and position or title held on behalf of the bidder.
 - c. Name, signature, and position or title of witness.
 - d. Completed attestation by Notary Public
- Note: Signer, Witness and Notary Public must be different individuals.**
7. The bid shall not contain any unauthorized additions, deletions, or conditional bids.
8. The Bidder shall not add any provision reserving the right to accept or reject an award, or to enter into a contract pursuant to an award.
