- It was made clear that this is not a normal bridge project that the Contractor is only responsible for the substructure/ abutment work, and excavation and erosion control associated with that. NCDOT will be completing the superstructure and roadway work.
- After the fact permit but best management will be enforced. Permit conditions will be addressed by NCDOT
- Contractor shall be responsible for any contract erosion control items during the substructure work but once that work in ICT 1 is completed, NCDOT will assume ownership of the erosion control.
- Existing Bridge Demolition will be done by NCDOT
- Construction Surveying will be done by NCDOT
- Contractor will not be responsible for placing the anchor bolts. NCDOT will place them after the contractor has completed their work.
- NCDOT will backfill for the abutments in coordination with the Contractor. The Contractor shall coordinate with Spencer McDonald <u>swmcdonald@ncdot.gov</u> when they complete each side up to the backfill needing to be placed. Once backfill is placed the Contractor shall be responsible for placement of the Rip Rap on the slopes.
- Lump Sum Grading Item has been eliminated
- Contractor shall haul waste material to NCDOT waste site, designated by the Engineer.
- Level 2 erosion control personnel shall be on site while the Contractor is responsible for the erosion control.




