Due to the tropical storm that passed through Western North Carolina earlier this week, not all potential bidders were able to attend the mandatory pre-bid conference that was held on September 17, 2018. As such, a second mandatory pre-bid conference is being held, and the letting date is being moved to accommodate this adjustment.

The above contract has experienced the following revisions:

- 1. On the Proposal Cover Sheet, revise the DATE AND TIME OF BID OPENING to read OCTOBER 23, 2018 AT 2:00 PM.
- 2. On page G-3, INSTRUCTIONS TO BIDDERS, under Item 10 of TRADITIONAL PAPER BIDS, revise the date to read October 23, 2018.
- 3. On page G-3, INSTRUCTIONS TO BIDDERS, under Item 11 1) of TRADITIONAL PAPER BIDS, revise the date to read October 23, 2018.
- 4. Revise SPD 1-310 on page G-4 with the following:

Only those bidders, whose names appear on the attendance sign-in sheet for the previous pre-bid meeting, are not required to attend this meeting.

5. Revise **SP1 G10 A** on page **G-5** with the following:

The date of availability for this contract is November 19, 2018.

The completion date for this contract is **November 18, 2019**.

- 6. Bidder questions and NCDOT Division answers:
  - a. Question 1: "Can we do a joint venture with contractor that did not come to pre-construction?"

## Answer 1: Joint ventures are acceptable, as long as at least one of the parties attended the mandatory pre-bid conference.

b. Question 2: "Can we do a joint venture with attendee of preconstruction?"

#### Answer 2: (See Answer 1 above).

c. Question 3: "Does the total amount of bid for the entire project need to be bonded? And or does the bid bond need to cover equipment capitalization / outfitting fee?"

# Answer 3: The bonds shall cover the entire bid amount, which includes the equipment capitalization / outfitting fees.
