







- Austin Phillips made comment all equipment need for needed for grading and placement of Class B Rip Rap would be incidental as stated in the standard spec book. This would be needed at exits 81 and 74 along US-74.
- Question by contractor; is fabric needed under Class B Rip Rap of ditch? Austin Phillips stated that it would not be necessary.
- Question by contractor; what color of mulch? Austin Phillips stated color would be natural, and mulch would need to be double ground and approved prior to placement.
- Bid date and package requirements discussed and confirmed.
- Federal requirements were discussed per contract.
