




N WALL INTERIOR EXISTING 2ND FLOOR




EXISTING REFLECTED CEILING 2ND FLOOR






S S WALL INTERIOR EXISTING 2ND FLOOR











FLOOR PLAN DEMO 1ST FLOOR SCALE: 1/2" = 1'-0"




CEILING DEMO 2ND FLOOR SCALE: 1/4" = 1'-0"












FLOOR PLAN NEW 1ST FLOOR A4 SCALE: 1/2" = 1'-0"


7. ALL NEW AND EXISTING CIRCUITS SHALL BE FIELD VERIFIED, TRACED, AND LABELED AT OUTLETS AND AT MAIN PANEL.

8. ADDED CIRCUIT M-15 SHALL USE I-T-E Q130, SINGLE POLE, 30A PLUG-IN BREAKER OR EQUIVALENT.


9. RG59 SHALL BE SPLIT AT OUTSIDE NEMA BOX WITH 3X INDIVIDUAL RUNS TO OUTLETS

10. TELEPHONE/DATA OUTLET SHALL BE RJ45, AT&T 258A / TIA 568 STANDARD TERMINATIONS

11. ALL WIRING SHALL BE CONCEALED IN-WALL WITH THE EXCEPTION OF THE SURGE PROTECTED CIRCUIT PROVIDED BY THE EXISTING CONSOLE. IF EXISTING CONSOLE RMC CANNOT BE REUSED, REPLACE WITH NEW. THHN CONDUCTORS SHALL BE REPLACED IF RMC CANNOT BE REUSED.
