SEALING EXISTING PAVEMENT CRACKS AND JOINTS:

Sealing of existing longitudinal and transverse pavement cracks and joints with hot applied joint sealer shall be performed in accordance with Section 657 of the Standard Specifications. Materials shall conform to Article 1028-2 of the Standard Specifications.

The bid quantities are approximate only and are to be used solely for the comparison of bids.

Measurement and Payment

Sealing Existing Pavement Cracks and Joints will be measured and paid at the contract unit price per pound for the appropriate rate. The appropriate rate will be determined on a per 20' Road Mile basis. Payment will be made only for the actual quantity of material satisfactorily placed.

Such prices shall include, but not be limited to, furnishing all labor, materials, tools, equipment, and other incidentals necessary to perform the required work.
