Pre Bid Meeting Notes

A Pre Bid meeting was held for the above referenced project on February 20, 2015 at 10:00 am on the project. Attached is a list of the attendees. The following topics were discussed;

- The date of availability for this contract is April 1, 2015. Work may start on or after this date.
- The completion date for this contract is June 1, 2015. Work must be completed on or before this date. No rain days will be granted.
- The linear footage given in the proposal is the actual number of linear feet of fence line that needs to be cleared.
- Clearing is to be done 2 feet on backside of fence and from the edge of the travel lane to the control access fence. **This is a change in the contract and will be on an Addendum**
- All vegetation less than 6" in diameter (as measured from ground level to 6 foot high) shall be cut as close to the ground as possible.
- All vegetation must be removed from the fence itself, such as vines growing in the fence.
- Any overhanging vegetation (such as tree limbs) are not required to be cleared.
- The clearing will be limited to the bank of the streams and no clearing is to be done in the waterways.
- Care needs to be taken to not damage the fence; however the NCDOT is aware that some damage may
 occur. An inspector will be onsite and will make sure the Contractor is taking measures to not cause
 damage.
- Grinding or chipping the vegetation is allowed, and the chips may be blown onsite if the size is small enough for a zero-turn type riding mower to go over them, without damage to the mower. All other vegetation cuttings must be removed and disposed of by the Contractor.

• At fence breaks continue clearing a long line of fence.
