Pre-Bid Meeting Notes

A Pre Bid meeting was held for the above referenced project on April 14, 2022 at 9:00 am at the Division 2 Construction Conference Room. Those in attendance are on the attached sign in sheet.

Ms. Moore began the meeting with reviewing the proposal. Items that were highlighted were;

- Bids are to be submitted electronically by 2:00 pm on April 27, 2022.
- Bonds are required.
- Date of Availability is June 27, 2022. Completion date for all work but vegetation is December 27, 2022. Completion date for vegetation to be established is March 27, 2022.
- Asphalt items are the Major Contract Items
- Minor Contract Items are Guardrail, Long-Life Pavement Markings (Thermoplastic), and Erosion Control.
- This is a Federally Funded Project and has all Federal Requirements.
- DBE goal is 3.0%
- Twelve-month guarantee is required.
- Jim Evans will place all final signing. Please provide 5 days notice for signing.
- There is a wattle required at the discharge of the new pipe. Turbidity Curtain and Erosion Control Stone may be required to be installed if too much erosion occurs.
- Page 2-1, mill and fill entire turn lane. Milling is for the full width section of the turn lane. Milling is not required on taper.
- Islands can be keyed in or surfaced mounted.
- Traffic Control is per the Roadway Standard Drawings.
- No Time restrictions for work or lane closures.

- Contractor can determine phasing of construction.
- Traffic can use bulb-outs with intermediate surface course.
- Final asphalt is a 2" lift.
- Old Washington Road is the next turn around from VOA.
