INVITATION TO BID ON PURCHASE ORDER CONTRACT

The North Carolina Department of Transportation is requesting bids for Cleaning and Painting of Bridge Substructures #8, #23, #29 in Jones County; #76, #77 in Lenoir County; and #42, #84 in Pitt County. The contractor must furnish all labor, materials, equipment, traffic control, and any other items necessary for the completion of this contract.

PRE-BID CONFERENCE

To ensure all prospective bidders are given an opportunity to obtain information relevant to the project, a **mandatory** pre-bid conference will be held on **Thursday**, **May 10**, **2012** at **2:00 PM**. The conference will be held at the Division 2 Office located at 105 Pactolus Hwy in Greenville.
