INVITATION TO BID ON PURCHASE ORDER CONTRACT

The North Carolina Department of Transportation is requesting bids for the bridge preservation consisting of pile encapsulation and repairs of Bridges #11 on SR 1230, #12 on SR 1005, and #21 on SR 1005 in Pamlico County. The contractor must furnish all labor, materials, equipment, and any other items necessary for the completion of this contract.
