## **Pre-Bid Meeting Notes**

A Pre Bid meeting was held for the above referenced project on September 1, 2016 at 10:00 am in the Division 2 Conference Room. Those in attendance are on the attached sign in sheet.

Mr. Godley began the meeting with reviewing the proposal. Items that were highlighted were;

- The importance of following the Instructions to Bidders to ensure your bid documents are correct.
- Penmanship when Bids are hand written
- Date of Availability (DOA) October 1, 2016 and Date of Completion (DOC) August 31, 2017.
- Intermediate Contract Time Number 1: No work shall be performed on this project on Sundays and Legal Holidays.
- Intermediate Contract Time Number 2: Cycle 1 (DOA) October 1, 2016 (DOC) January 31, 2017 Cycle 2 (DOA) May 1, 2017 (DOC) August 31, 2017
- Contractor is responsible for traffic control and meeting the requirements.
- The Contractor's operations are restricted to daylight hours.
- Safety vests must be worn at all times while on the project. The Department may assess a fine of \$100 for each occurrence of a violation. This fine is separate from any fines that may be given by OSHA.
- Contractor shall provide one permanent English speaking employee who shall have authority and capability for overall responsibility of the project and who shall be personally available at the work site within 24 hours' notice.
- Litter pick-up shall be performed on all areas. There shall be no direct payment for litter pick-up, as this work will be considered incidental to the contract.
