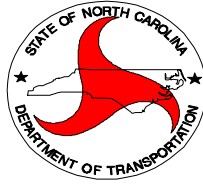

When the contractor is notified that a new installation of either guardrail or guiderail is necessary work shall begin within thirty (30) calendar days of notification. In the event that the Contractor fails to respond within the specified period that a new installation is needed, liquidated damages in the amount of Two Hundred Dollars (\$200.00) per calendar day will be charged against the Contractor for each calendar day beyond the allotted time as stated above for which he fails to respond.

The provisions of Articles 102-10 and 103-7 of the 2012 Standard Specifications for Roads and Structures are waived for this project. No bonds required.

**PAYMENT:**
