The availability date for this project is March 7, 2016. The construction completion date is June 30, 2016.

Effective July1, 2014, Division Let contract should be only awarded to firms listed in the <u>Directory of Transportation Firms</u> as either a Bidder or PO Prime Contractor. After this date, firms that are prequalified as subcontractor only cannot bid on Division let projects.
