## **NOTICE TO PROSPECTIVE BIDDERS**

**Subject: Invitation to Bid** 

- **Project Description:** Sunset Beach Roundabout Grading, Drainage and Paving.
- WBS Element #: 43812 and 43853.3.1

The North Carolina Department of Transportation is requesting bids for the Roundabout at the intersection of NC 179 Business and SR 1172 (Sunset Blvd.) in Sunset Beach, NC. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

The availability date for this project is February 24, 2014. The completion date is June 21, 2014.

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday, January 30, 2014. Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

QUOTATION FOR WBS ELEMENT # 43812 and 43853.3.1: Roundabout at the intersection of NC 179 Business and SR 1172 (Sunset Blvd.) in Sunset Beach, NC TO BE OPENED AT 2:00 PM ON THURSDAY, January 30, 2014.

Beginning July 1, 2009, any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified <u>prior to submitting a bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior to beginning work on the project</u>.

For the purposes of prequalification, any firm that is currently prequalified as a prime or a subcontractor on central let projects for the appropriate work codes is considered eligible

to work and/or bid on Purchase Order Contracts as long as other items such as bonding and license requirements for the contract are met.

The North Carolina Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights of 1964 (78 Stat.252) and the Regulations of the Department of Transportation (49 C.F.R., Part 21), issued pursuant to such act, hereby notifies all bidders that it will affirmatively insure that the contract entered into pursuant to this notice will be awarded to the lowest responsible bidder without discrimination on the grounds of sex, race, color, or national origin.

Statements of Minority and Women Business Enterprises participation must be presented with the bids. MBE goals are 5.0%, and WBE goals are 3.0% for this contract.
