**NOTICE TO PROSPECTIVE BIDDERS**

**Subject: Invitation to Bid**

- ***Project Description:*** Sod and Tree installation, Clinton NC
- ***WBS Element #:*** 3703.3.20

The North Carolina Department of Transportation is requesting bids for Sodding area near intersection of McKoy St & Northwest Blvd., planting of Crape Myrtles at intersection of McKoy St. and Northwest Blvd., McKoy St. and Sampson St., removal of pampas grass at intersection of McKoy St. and Northwest Blvd.

**The availability date for this project is March 17, 2014. The completion date is June 13, 2014.**

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday, February 20, 2014. Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

**QUOTATION FOR WBS ELEMENT #3703.3.20**

Beginning **July 1, 2009**, any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified prior to submitting a bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.

For the purposes of prequalification, any firm that is currently prequalified as a prime or a subcontractor on central let projects for the appropriate work codes is considered eligible to work and/or bid on Purchase Order Contracts as long as other items such as bonding and license requirements for the contract are met.


