The North Carolina Department of Transportation is requesting bids **for Surfacing**, **Resurfacing**, **Leveling**, **Widening**, **Milling and Patching on Various Roads upon Request in Sampson County**. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control. At the option of the Department, this contract may be extended for two (2) additional periods of one (1) year each

(maximum (3) three years total).

The availability date for this project is April 24, 2017. The completion date is April 23, 2018.
