The North Carolina Department of Transportation is requesting bids **for Surfacing**, **Resurfacing**, **Leveling**, **Widening**, **Milling and Patching on Various Roads upon Request in Duplin County**. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control. At the option of the Department, this contract may be extended for two (2) additional periods of one (1) year each

(maximum (3) three years total).

The availability date for this project is April 24, 2017. The completion date is April 23, 2018.

## **BID OPENING**

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on **Thursday March 16, 2017**. Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

Effective July 1, 2014, Division Let contracts should only be awarded to firms listed in the <u>Directory of Transportation Firms</u> as either a Bidder or PO Prime Contractor. After this date, firms that are prequalified as subcontractors only cannot bid on Division Let projects.
