The North Carolina Department of Transportation is requesting bids for a contract: <u>Replace</u> <u>Duplin Bridges #063 and #155 in Duplin County.</u> The project will include construction of various concrete items per direction of the County Maintenance Engineers. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

The availability date for this project is May 1, 2017.

The completion date is June 18, 2018.
