NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid

- ***Project Description:*** Surfacing, Resurfacing and Widening on Various Roads in Sampson and Duplin Counties.
- ***WBS Element #:*** 3.108211, 3.208211 and 3.103111, 3.203111

The North Carolina Department of Transportation is requesting bids for Surfacing, Resurfacing and Widening on Various Roads Upon Request in Sampson and Duplin Counties. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

The availability date for this project is May 20, 2013. The completion date is December 15, 2013.

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday, May 2, 2013. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

QUOTATION FOR WBS ELEMENT # 3.108211, 3.208211 and 3.103111, 3.203111: Surfacing, Resurfacing and Widening on Various Roads Upon Request in Sampson and Duplin Counties. TO BE OPENED AT 2:00 PM ON Thursday, May 2, 2013.

Beginning **July 1, 2009**, any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified prior to submitting a bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.

For the purposes of prequalification, any firm that is currently prequalified as a prime or a subcontractor on central let projects for the appropriate work codes is considered eligible to work and/or bid on Purchase Order Contracts as long as other items such as bonding and license requirements for the contract are met.
