**NOTICE TO PROSPECTIVE BIDDERS**

**Subject: Invitation to Bid**

- ***Project Description:*** US 74-76 Wrightsville Beach NC, Wrightsville Beach Landscape Enhancement
- ***WBS Element #:*** 3703.3.37

The North Carolina Department of Transportation is requesting bids for landscape enhancement at various sites on US 74-76 Causeway Drive in Wrightsville Beach. The job will include planting, irrigation, and installation of retaining wall, garden wall, and cobblestone paver edge.

**The availability date for this project is June 9, 2014. The completion date is August 29, 2014.**

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday, May 15, 2014. Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

**QUOTATION FOR WBS ELEMENT #3703.3.37 "Wrightsville Beach Landscape Enhancement"**

Beginning **July 1, 2009**, any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified prior to submitting a bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.

For the purposes of prequalification, any firm that is currently prequalified as a prime or a subcontractor on central let projects for the appropriate work codes is considered eligible to work and/or bid on Purchase Order Contracts as long as other items such as bonding and license requirements for the contract are met.
