The North Carolina Department of Transportation is requesting bids to Grade, Drain, Upgrade Intersection, Mill, Condition Existing Base and Pave and Resurface in Onslow County. The project will include approximately 15.928 MSY of Conditioning Existing Base, 30067 SY of various depth Milling, 410 tons of B25.0 B Asphalt, 35 tons of I 19.0 B Asphalt, 2585 Tons of S 9.5 B Asphalt and 650 Tons of SF 9.5 A Asphalt. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

# The availability date for this project is JUNE 15, 2015. The completion date is NOVEMBER 6, 2015.

Beginning **July 1, 2009**, any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform.
