The North Carolina Department of Transportation is requesting bids for the **State Funded Replacement of Pender County Bridge #45** with a concrete box culvert. The contractor must furnish all labor, materials, traffic control, personnel and equipment.

The Department of Transportation does not exclude any person from participation in, deny any person the benefits of, or otherwise discriminate against anyone in connection with the award and performance of any contract covered by this program on the basis of race, color, sex, political affiliation/ influence, or national origin.

BID OPENING

Sealed bids must be received at the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 on Thursday, May 21, 2015 by 2:00 pm. Bids must be submitted on the official bid form included in the contract proposal and shall display the following statement on the front of the bid envelope:

The availability date for this project is **July 6, 2015**. The construction completion date is **October 5, 2015**. This project is subject to the Permanent Vegetation Establishment special provision, which holds the contractor responsible for 80% permanent vegetative coverage within 180 days following the structure completion, no later than April 3, 2016.

The North Carolina Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights of 1964 (78 Stat.252) and the Regulations of the Department of Transportation (49 C.F.R., Part 21), issued pursuant to such act, hereby notifies all bidders that it will affirmatively insure that the contract entered into pursuant to this notice will be awarded to the lowest responsible bidder without discrimination on the grounds of sex, race, color, or national origin.

Statements of Minority and Women Owned Business Enterprise participation must be presented with the bids. MBE goals are 3.0% and WBE goals are 2.0% for this contract.


