The entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

Effective July 1, 2014, Division Let contracts should only be awarded to firms listed in the <u>Directory of Transportation Firms</u> as either a Bidder or PO Prime Contractor. After this date, firms that are prequalified as subcontractors only cannot bid on Division Let projects. Within 14 Calendar Days After Notice Of Award Is Received, The Successful Bidder Shall Submit A Fully Executed Execution Of Contract, Non-Collusion Certification, Debarment Certification And Gift Ban Certification Signature Sheet.

CONTRACTOR'S LICENSE: A General Contractor's License Is Required In Order To Submit A Bid On Any Non-Federal Aid Project Where The Bid Is \$30,000.00 Or More, Except For Certain Specialty Work As Determined By The Licensing Board. <u>On Federal Projects</u>, The Appropriate Contractors License Shall Be Obtained Within 60 Days Of Bid Opening. C. All Required Prequalification Statements And Documents Shall Be Filed With The Contractual Services Unit At Least Four Weeks Prior To The Date Of Opening Bids.

The North Carolina Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights of 1964 (78 Stat.252) and the Regulations of the Department of Transportation (49 C.F.R., Part 21), issued pursuant to such act, hereby notifies all bidders that it will affirmatively ensure that the contract entered into pursuant to this notice will be awarded to the lowest responsible bidder without discrimination on the grounds of sex, race, color, or national origin.
