Effective July 1, 2014, Division Let contracts should only be awarded to firms listed in the <u>Directory of Transportation Firms</u> as either a Bidder or PO Prime Contractor. After this date, firms that are prequalified as subcontractors only cannot bid on Division Let projects. Within 14 Calendar Days After Notice Of Award Is Received, The Successful Bidder Shall Submit A Fully Executed Execution Of Contract, Non-Collusion Certification, Debarment Certification And Gift Ban Certification Signature Sheet.

CONTRACTOR'S LICENSE: A General Contractor's License Is Required In Order To Submit A Bid On Any Non-Federal Aid Project Where The Bid Is \$30,000.00 Or More, Except For Certain Specialty Work As Determined By The Licensing Board. On Federal Projects, The Appropriate Contractors License Shall Be Obtained Within 60 Days Of Bid Opening. C. All Required Prequalification Statements And Documents Shall Be Filed With The Contractual Services Unit At Least Four Weeks Prior To The Date Of Opening Bids.
