The entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

The availability date for this project is August 28, 2017. The completion date is June 29, 2018.

After this date, firms that are prequalified as subcontractors only cannot bid on Division Let projects.
