The North Carolina Department of Transportation is requesting bids for the **Federally Funded Bridge Preservation Project on New Hanover County Bridge #8**. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

BID OPENING

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday, September 4, 2014. Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

The availability date for this project is **October 6, 2014**. The construction completion date is **November 21, 2014**.

Effective July 1, 2014, Division Let contracts should only be awarded to firms listed in the [Directory of Transportation Firms](#) as either a Bidder or PO Prime Contractor. After this date, firms that are prequalified as subcontractors only cannot bid on Division Let projects. Statements of Disadvantaged Business Enterprises participation must be presented with the bids. DBE goals are 0.0% for this contract.


