**Subject: Invitation to Bid** 

Project Description: Micro-Surfacing and Paint Markings on SR-1301 (Rand St./Richlands Loop Rd) and SR-1302 (Huffmantown Rd) in Onslow County.

The North Carolina Department of Transportation is requesting bids for Micro-Surfacing and Paint Markings on SR-1301 (Rand St./Richlands Loop Rd) and SR-1302 (Huffmantown Rd) in Onslow County. The project will include approximately 86,321 SYDs of Latex Modified Micro-Surfacing Type II; 86,321 SYDs of Micro-Surfacing Type III, and 282,504 LF of striping. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

The availability date for this project is September 24, 2012. The completion date is October 31, 2012.

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday, **September 6, 2012**. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

Beginning **July 1, 2009**, any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified

for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified <u>prior to submitting a bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior to beginning work on the project</u>.

For the purposes of prequalification, any firm that is currently prequalified as a prime or a subcontractor on central let projects for the appropriate work codes is considered eligible to work and/or bid on Purchase Order Contracts as long as other items such as bonding and license requirements for the contract are met.
