The North Carolina Department of Transportation is requesting bids for a **cut and shove crew for removal of storm related debris from state maintained roadways contract.** All quantities are estimates only. The Contractor MUST furnish labor, equipment, materials and traffic control.

Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

Effective July 1, 2014, Division Let contracts should only be awarded to firms listed in the <u>Directory of Transportation Firms</u> as either a Bidder or PO Prime Contractor. After this date, firms that are prequalified as subcontractors only cannot bid on Division Let projects.
