The North Carolina Department of Transportation is requesting bids for a **Grading**, **Drainage and Sidewalk Construction in Burgaw**. All quantities are estimates only. The Contractor MUST furnish labor, equipment, and traffic control.

The entire bid package with the Base Bid and Alternate Bid must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

The availability date for this project is January 9, 2017. The completion date is June 16, 2017.

Effective July 1, 2014, Division Let contracts should only be awarded to firms listed in the <u>Directory of Transportation Firms</u> as either a Bidder or PO Prime Contractor. After this date, firms that are prequalified as subcontractors only cannot bid on Division Let projects.
