The North Carolina Department of Transportation is requesting bids to Rehab Existing Storm Sewer by Installing CIPP Liners in Onslow, Pender, Brunswick, New Hanover, Duplin & Sampson Counties. The project may include 15" Pipe Liner, 18" Pipe Liner, 24" Pipe Liner, 30" Pipe Liner, 36" pipe Liner, 42" Pipe Liner and 48" Pipe Liner. It will also include Pipe Cleanout & Camera. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

**The availability date for this project is January 1, 2015. The completion date is December 31, 2015.**


